PRIMARY RECAP

April 23 marked the date of the 2024 Primary. This included the presidential contest (Were you surprised at the outcome?), congressional, PA State Senate (1/2 of the seats were up), PA House of Representatives, and row offices of Attorney General, Auditor General, and State Treasurer. Current and former House legislators figured prominently in some of the other contests.

Attorney General: Former Rep. Eugene DePasquale bested four other Democratic candidates to win with 35.6% of the vote. DePasquale also served as PA's Auditor General. A point of interest in this race is that both DePasquale and his general election opponent District Attorney David Sunday hail from York County. Current Rep. Jared Solomon (D-Phila.) also ran for the Democratic nomination but garnered only 13.1% of the vote. In the Republican primary, David Sunday defeated Rep. Craig Williams (R-Delaware/Chester) by 70.4% to 29.6%.

Auditor General: Current Rep. Malcolm Kenyatta (D-Phila.) won the Democratic primary with 64.25% of the vote. He is running against incumbent Republican Tim DeFoor in the general election. DeFoor was unopposed in his primary.

State Treasurer: Erin McClellan bested current Rep. Ryan Bizzarro (D-Erie) 54.3% to 45.7% in the Democratic primary. She will oppose incumbent Republican Stacy Garrity in the general election. Garrity was unopposed in her primary.

NOTE: A provision in PA law is that legislators may file for another office while also filing in his or her respective primary for re-election as lawmaker. These include Rep. Kenyatta whose win would will mean a special election for the 2025-26 session of the General Assembly. Democrat Representatives Solomon and Bizzarro did not win the nomination for higher office but they did win their primary for State Representative and will appear on the fall ballot. Ditto for Rep. Craig Williams who was defeated in his quest for the Attorney General GOP nomination but won the nomination for his House seat.

Other state representatives seeking nominations for Congress won their primaries but did not file for reelection to the PA House: Rep. Ryan Mackenzie (R-Lehigh) will face incumbent Democratic U. S. Rep. Susan Wild in November. Rep. Robert Mecuri (R-Allegheny) is running against incumbent Democratic U.S. Rep. Chris DeLuzio this fall.

All incumbent U.S. Members of Congress either won their primary or were unopposed.

Takeaways from Senate Primary

• 13 of the 25 seats have no opposition from the primary. That is, 8 Republicans and 5 Democrats are right now unopposed for the general election in November.

Open Senate Seats

- **15th District's** core is Dauphin County with a 2023 party registration of 85,589 Democrats, 73,756 Republicans, and 30,819 others. Redistricting gave it some Republican areas in the West Shore in Cumberland County but the district lost Republican Perry County. Current Democratic Rep. Patty Kim is facing off against Dauphin County Treasurer Republican Nick DiFrancesco. Current Senator Republican John DiSanto did not seek re-election.
- **31**st **District** includes York and Cumberland Counties. The two counties have Republican voter registration majorities. Nominees are current Republican Rep. Dawn Keefer, Chair of the House Freedom Caucus. Her opponent is Democrat Mark Temons. He is a carpenter. The current Senator is Republican Mike Regan who did not seek re-election.
- 45th District is centered in Allegheny County. It was redistricted to remove more-GOP-leaning Westmoreland County giving Democrats a voter registration advantage. Over all, Allegheny County has 509,736 registered Democrats versus 254,416 Republicans in 2023. Other affiliations totaled 131,890. This margin may be offset by Democrats voting 'Red' as they have in the last two presidential elections. Democratic candidate is current Rep. Nickolas Pisciottano. Republicans nominated Jennifer Dintini. as their standard-bearer. She is the founder of a woman-owned security firm. Incumbent Democratic Senator Jim Brewster did not seek re-election.

PA House 2024 Primary

Because all House 203 seats are up for election in 2024, please refer to the PA Department of State for vote totals. (Go to https://www.electionreturns.pa.gov/ and click on Offices at the top of that page.)

NOTE It is not formatted to show which counties are included in a district or what municipalities or counties are the candidates' homes. Clicking on the incumbent legislator's name with give you the counties in his or her district.

Some general information:

- House candidates (both incumbents and candidates for open seats) who were unopposed in their own party's primary include 136 Democrats and 122 Republicans.
- There were numerous races where there was no opponent in the opposing primary. Although right now, there is no November opponent, these numbers will change after political party appointments are made to fill those vacancies.
- 109 House candidates are currently unopposed for the general election. They include 60 Democrats and 49 Republicans. That is over one-half of the 203 legislative seats in the House.
- There are currently 15 open seats, 5 currently held by Democrats and 10 by Republicans with one uncertain district (117th).
- Two incumbents failed to win the primary election. They are Rep. Kevin Boyle (D-Phila.) and Rep. Jim Gregory (R-Blair).
- The 117th district (Luzerne County) shows incumbent Mike Cabell (R) losing to challenger James Walsh in the GOP primary by eight votes, 4,723 to 4,715.
- Other close vote races:
 - 10th District (Dem.) Amen Brown defeated Cassandra Green by 50 votes (2,959 to 2,909).
 - 38th District (Dem.) John Inglis defeated Victoria Schmotzer by 48 votes (3,180 to 3,132).

REPUBLICAN WINS SPECIAL HOUSE ELECTION

As anticipated in this Republican district, GOP candidate Jeff Olsommer sailed to victory over Democrat Robin Skibber by 60% to 40% (7,146 to 4,702 votes). He will not be sworn in or assigned to committees until after the House reconvenes on April 29. The Representative-elect replaced fellow Republican former Rep. Joe Adams in this northeastern district who resigned due to a family situation. The special election winner fills out Adams' term until November 30, 2024. Olsommer must stand for re-election in November.

Olsommer is a licensed insurance producer.

Once again, Republicans are one vote away from regaining House control, at least until another special election would be called if Rep. Kevin Boyle (D-Phila.) is forced to resign due to a range of personal issues. There was one partisan matter that boiled over independent of Rep. Boyle's legal woes. Democratic leaders allowed Boyle to vote absentee even as an police arrest warrant was in effect. Most recently, the police warrant was cancelled. Republicans cried foul and said that allowing his remote vote was an improper use of power.
