SENATE RETURNS ON AUGUST 30

The Senate is resuming its business on August 30. As of this writing, there is only the one date listed but that could easily change depending on resolution of Fiscal Code legislation that would release some or all of the sequestered Funds and new programs contained in the FY 2023-24 State Budget.

It is a fluid situation. There are eight other agenda items on third consideration (ready to be voted on) and 13 bills on second consideration (needs one more session before a final vote can be taken in the Senate). None directly concerning Insurance are on the calendar for third consideration. There are two bills listed as up for second consideration of interest to the Insurance Community:

- **Senate Bill 365** (Bartolotta-R-Beaver/Greene/Washington) provides for Workers Compensation coverage for post-traumatic stress injury.
- **Senate Bill** (Vogel-R-Beaver) regulates Telemedicine and requires health insurance coverage for those claims.

Note that the Senate may choose to consider all or none of these bills on the calendar if leadership decides to focus solely on the Fiscal Code legislation. There are two Fiscal Code bills on second consideration now, each of which could be amended and serve as a vehicle for the sequestered funds language. The bills are **Senate Bill 817** (Brooks-R-Mercer/Crawford/Lawrence) which deals with workforce matters concerning Federally Qualified Health Centers and **Senate Bill 802** (Farry-R-Bucks) which would establish the Redevelopment Authority Startup Loan Program.

COMMITTEE WORK...

Eight committee meetings are scheduled between now and September 8. Neither the House Insurance Committee nor the Senate Banking & Insurance Committees have scheduled meetings. Being held are hearings/informational meetings on topics ranging from career and technical education (House Democratic Policy Committee, Aug. 29) to invasive species (House Agriculture & Rural Affairs Committee, Sept. 8).

REGULATION UPDATES

- The PA Compensation Rating Bureau issued a release on August 22 stating that the PA Insurance Department approved, as filed, the PCRB's proposed PA Experience Rating Plan Revisions effective April 1, 2024. Details: PCRB Circular No. 1799 and Filing No. 340 at www.pcrb.com.
- On October 16, the PA Insurance Department and the Governor's Office issued a reminder for insurers and consumers that insurance companies and Pennie, the PA health insurance exchange, are required to cover breastfeeding essentials such as pumps and counseling. This coverage does not have a co-pay, deductible, or coinsurance.
- National Association of Insurance Commissioners issued media releases of interest. First, NAIC voted to adopt a change to the Life Risk-Based Capital formula. This followed approvals by the NAIC Capital Adequacy Task Force and the Financial Committee. NAIC stated that the estimated change in the RBC ratio of life insurers "is very small." The second release concerned an NAIC announcement that it plans a data call to "assist state regulators in collecting insurer data in better assessing their markets and insurer underwriting practices by developing property market...(performance) and identify new coverage gaps, deductible changes and coverage types, and affordability and availability issues."
